Product description and application

This Type Approval covers the untwisted E7-390 direct roving with E7 glass formulation for weaving and filament winding of FRP components of wind turbine generators (rotor blades, nacelle covers, spinners). The E7-390 direct roving has a silane-based sizing for amine and anhydride curing epoxy systems.

Approved variants

This Type Approval covers the direct roving E7-390 with silane-based sizing for amine and anhydride curing epoxy systems with the linear densities 300tex, 600tex, 1200tex, and 2400tex and filament diameters of 13μm or 17 μm:

E7DR13-300-390: 13μm E7DR17-600-390: 17μm E7DR17-1200-390: 17μm E7DR17-2400-390: 17μm

Limitations for the product

The E7 glass formulation is not an E-glass formulation as per ASTM D 578 definition. Additional testing might be required depending on the intended field of application.

The approval is limited for application of the product in blades of wind turbines.

Any significant changes in design and/or quality of the material will render the approval invalid.
